Mayor Draper informed the Council that the trash cans purchased for each customer with ARP monies are scheduled to arrive June 28. At that time a plan to record the serial numbers and distribute the trash cans will be implemented.

AGENDA ITEM 10: DEPARTMENT REPORTS

- A. TOWN ENGINEER- Not present**
- B. UTILITY DEPARTMENT- Charles Carter:** Mr. Carter informed the Council that there had been several severe water leaks the department had to work on. He told the Council that finding fittings for the old transite pipes has become increasingly difficult. Mr. Carter also stated he is still working on addressing the issues DHH found in their April inspection.
- C. SEWER PLANT – Charles Carter:** Mr. Carter said the sewer plant is working normally, although he had observed red worms in the drying beds and would have to address that problem. Mr. Carter did say that it was becoming increasingly difficult to maintain the old equipment at the plant. He also reiterated that he was worried about the lift stations where some of them had only one pump operational.
- D. STREET DEPARTMENT – Dana Smith:** Mr. Smith told the Council they had been working diligently to stay on top of grass cutting. They also had been addressing complaints about potholes and low-hanging trees.
- E. FIRE DEPARTMENT – Dana Smith:** Chief Smith informed the Council and Mayor that they had mostly medical calls in the month of May. The fire department was also having a fund-raising jambalaya lunch on June 18, 2022 from 10:30 AM to 12:30 PM.
- F. POLICE DEPARTMENT – Chief Daniel Firmin:** Chief Firmin informed the Council that there were 56 citations and 5 arrests in the month of May. Mayor Draper asked the Chief how the new radios were holding up. Chief Firmin said they needed new sets of batteries for the radios.
