SIMMESPORT ALDERMANIC REDISTRICTING PLAN A

Aldermanic District Ordinance

ORDINANCE NO. 05-2023-01

The following Ordinance was offered by Alderman Turner who moved its adoption: An ordinance redistricting the Simmesport Board of Aldermen Districts to adjust said district boundaries as defined by Plan A (*see attached map*) for Population changes documented by the 2020 United States Decennial Census and providing for other related Matters; and repealing any and all ordinances in conflict herewith.

THE SIMMESPORT BOARD OF ALDERMEN HEREBY ORDAINS:

Section 1. That, in accordance with the Louisiana State Revised Statute 33:1371, the boundaries of the Simmesport Board of Aldermen districts are hereby redistricted to provide for population equality among the districts as near as reasonably practicable by the adoption and ratification of the document attached hereto and made a part hereof.

Section 2. That the Board of Aldermen district boundaries as redistricted in Section 1 above shall become effective for the qualification and election of candidates for the Simmesport Board of Aldermen in the year 2024, and for all purposes upon the assumption of office by the members of the Simmesport Board of Aldermen in the year 2025.

This ordinance was introduced through Resolution of the Board of Aldermen of the Town of Simmesport during the regularly scheduled meeting of the Board of Aldermen on May 8, 2023, by **Alderman Turner**, with a second to the motion by **Alderman Wright**, and the Board of Alderman then **passed** the resolution introducing this Ordinance and scheduling a public hearing for June 12, 2023 at 5:30 PM by the following vote:

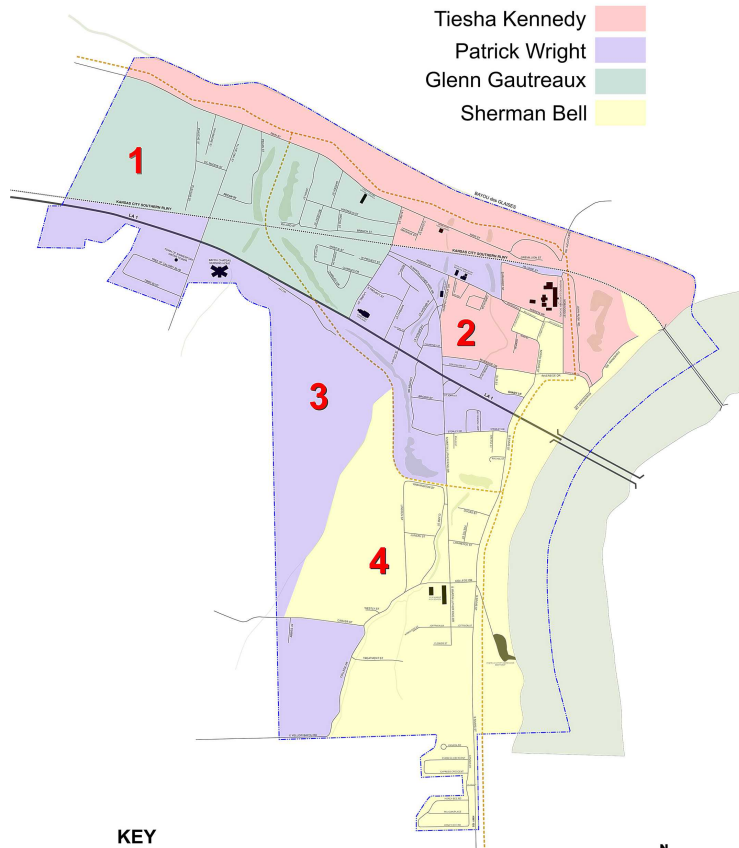
